## MSF leader expresses regret over 'sexist' remark against some women members

**THIRUVANANTHAPURAM, AUG 26** --/ A top leader of the Muslim Students Federation (MSF), who is facing charges of using derogatory remarks against some of the women members of the outfit during a recent meeting, on Thursday expressed regret over the incident, but stuck to his claim that he did not use any word with malicious intent.

P K Navas, the president of MSF, the students' wing of the Indian Union Muslim League (IUML), came up with a Facebook post detailing his version of the issue, which had triggered a widespread row in the state putting the organisations in a fix. He claimed that he did not make any "personal or gender-specific" remark against anyone during the recent state committee meeting of the MSF, as alleged by the leaders of Haritha, the women's wing of the outfit. "I did not utter a single word with malicious intent during the meeting, which was attended by around 30 people including a woman activist. I express my regret if any of my colleagues who took part in the meeting were hurt due to misunderstanding or otherwise," he said in the FB post.

Navas said if the issue had been raised or protest was registered in the meeting, he would have been prepared to correct the misunderstanding then itself or even apologise if necessary.

Noting that he did not react to the controversy so

far as he did not want to violate the party discipline, he also wished that the controversy would end here forever.

A group of Haritha leaders had recently petitioned the state Women's Commission against the objectionable remarks allegedly used by some of the male leaders of the outfit, including Navas. They said they had approached the rights panel as the IUML leadership failed to take any timely action against the 'guilty'.

As the issue had triggered a row putting the IUML and its allied organisations in a fix, the party leadership had last week decided to freeze the state committee of "Haritha".

Fathima Thahiliya, the national vice president of the MSF and a founding leader of Haritha, came out against the decision and said they did not get "natural justice" (PTI).

## Assembly polls: Chidambaram finds atmosphere 'extremely favourable' for Cong in Goa in 2022

**PANAJI, AUG 26** --/ Former Union minister P Chidambaram on Thursday said the Congress was getting "battle-ready" to fight all 40 seats in the Goa Assembly elections due in February next year, and claimed that the political atmosphere in the state was "extremely favourable" for the party.

Addressing a press conference, the newly-appointed AICC election observer for Goa also expressed confidence that the Congress would form the next government in the state after the polls, but any decision on aligning with the like-minded parties would be taken at an appropriate time. "Congress party is getting battle-ready for the Goa Legislative Assembly election scheduled next year. Initial assessment is that the political atmosphere is extremely favourable for Congress in all the constituencies. There are indications that there will be change in government and the new government will be led by Congress party," he said. The people of Goa expect that there should be a change in the government and the Congress party will not disappoint them, he added. Chidambaram said the party will field such candidates, who are "loyal and faithful to the ideology of the party, hardworking and ready to serve the interest of the people of Goa". He also said that the party will find many aspirants in each constituency, but the decision about giving candidature will be taken only after consulting the active members of each block in the constituency, including those belonging to the Youth Congress, Mahila Congress, Seva Dal and other wings. When asked about the change in party leadership in the state and whether Goa Pradesh Congress Committee President Girish Chodankar would be replaced, the party veteran said, "I am not here to replace anyone. Such organisational matters are discussed and decided at the appropriate time." (PTI)

## NGT raps UPPCB for delay in submitting report on sewage discharge into Ganga

**NEW DELHI, AUG 26** --/ The National Green Tribunal has rapped the Uttar Pradesh Pollution Control Board (UPPCB) for delay in submitting a report on specific liability of industries on sewage discharge containing toxic chromium into Ganga at Rania and Rakhi Mandi in Kanpur.

A bench headed by NGT Chairperson Justice Adarsh Kumar Goel said more than six months have passed and the UPPCB has not yet passed any order on the subject on a specious plea that proceedings are still pending. Such an attitude can hardly be appreciated and the situation needs to be remedied by the concerned supervising authorities, the NGT said. "Let the UPPCB

now finalise the matter and pass its order on or before September 30, 2021 and file the same before this tribunal. The appellants are at liberty to file their objections, if any, to the said order within 15 days thereafter," the bench said in a recent order. The NGT had earlier slammed the UP government for failing to check sewage discharge containing toxic chromium into Ganga at Rania and Rakhi Mandi in Kanpur and imposed a penalty of Rs 280 crore on 22 tanneries for causing pollution.

It had also held the UP government liable and slapped a penalty of Rs 10 crore on it. The green panel had said the

problem has not been tackled for the last 43 years and it has resulted in contamination of ground water affecting the health and life of the inhabitants. The compensation of Rs 280.01 crore was assessed by the UPPCB. It had also held UPPCB liable and directed it to pay Rs 1 crore for ignoring illegal discharge of sewage and other effluent containing toxic chromium directly into Ganga. "UP Jal Nigam is held liable to pay a sum of Rs 1 crore for releasing untreated large quantity sewage

containing toxic chromium in Ganga. These amounts may be deposited with the Central Pollution Control Board (CPCB) within one month which may be overseen by the UP chief secretary," the bench had said.

The order came after perusing two reports filed by Justice Arun Tandon, former Judge of the Allahabad High Court, who had been appointed as head of a Committee to oversee the compliance of Ganga cleaning. Justice Tandon along with the representatives of the National Mission for Clean Ganga, the CPCB, state pollution control board, UP Jal Nigam and the local residents of the area, visited the sites and noticed the status of the Rania and Rakhi Mandi in Kanpur. Taking strong note of the report, the tribunal said, "The above report is self-speaking and paints a grim picture of failure of the authorities in taking remedial measures, forcing the inhabitants to drink polluted water which is a serious hazard to their health.
